The Dog Spot New Member Agreement

I hereby certify that I am the owner of _____, the dog(s) which will participate in Doggy daycare and/or boarding. I also understand that this is a legally binding contract between The Dog Spot and the pet owner whose signature appears below. I agree to pay for all charges incurred upon pick-up.

HOURS:

I understand that The Dog Spot hours are as follows:

Monday-Friday 7:00am-5:00pm (Daycare check-in 7:00am-9:30am only)

Saturday 7:00am-10:00am & 3:00pm-5:00pm

Sunday: 4:00pm-6:00pm (Drop-off / pick-up only)

I understand the prices are clearly posted in the lobby but are subject to change and non-negotiable. I understand that late fees will strictly be enforced as follows:

Daycare:

Check-out time is between 4:00pm and 6:00pm.

If I pick my pet up after check out time, I will be charged one dollar per minute. If The Dog Spot closes prior to my arrival, my pet will be boarded and I will pay the late fee and additional boarding and daycare fees as they apply. Late charges must be paid at the time of pick up.

Boarding:

Monday-Friday: check-out is no later than 6:30pm.

Saturday: check-out is between 3:00pm and 4:45pm.

Sunday: check-out is between 4:00pm and 5:45pm.

I understand that if I pick up my pet after check out time, I will be charged an additional late fee of \$20 (twenty dollars). If The Dog Spot closes prior to my arrival my pet will be boarded and I will pay the late fee and additional boarding and daycare fees as they apply. Late charges must be paid at the time of pick up.

MEDICAL EMERGENCY:

I understand that in the event of a medical emergency The Dog Spot will attempt to contact me and my emergency contact(s) as listed on the new member application; however, if no one listed can be reached, The Dog Spot, at it's sole discretion, will obtain medical treatment at the closest available veterinary facility.

I further agree that I am financially responsible for any medical treatment my pet(s) receive(s) as a result of a medical emergency while at The Dog Spot.

I authorize The Dog Spot to do the following as indicated by my initials:

- _____A) Do ANYTHING needed for my pet's health as deemed necessary by the examining veterinarian REGARDLESS of cost.
- _____B) Do anything needed for my pet's health as deemed necessary by the examining veterinarian but with a cost not to exceed \$_____ (_____).
- _____C) Please keep my pet as comfortable as possible, but do not do any extra veterinary care until I am contacted.

I understand that my pet(s) must be friendly towards other pets and people. He/She must not be food or toy aggressive. Owners certify that their pet(s) have not harmed, caused death or shown aggression towards any person or animals. I understand that if my pet has a history of aggression or biting, The Dog Spot reserves the right to refuse service, and that all bites will be reported to the local authorities as required by law. I have disclosed to The Dog Spot all known dangers associated with my pet.

REQUIREMENTS:

Vaccines:

To prevent the spread of disease while my pet is at The Dog Spot, he/she must be current on all core vaccines or titers as dictated by the pet's veterinarian: DHPP, Bordatella, Rabies, etc. Vaccines will be accepted up until the day of admittance. To make sure your dog is fully protected, we recommend injectable vaccines be given at least 5-7 days before admittance and intranasal vaccines be given at least 72 hours before admittance.

Prevention:

All dogs who set foot in the building for any service must be on heartworm prevention and flea / tick prevention.

Puppies:

Puppies can not be accepted until they have received a full series of puppy vaccines starting between 6 - 8 weeks and given every 3 - 4 weeks until 20 weeks of age. This is to prevent The Dog Spot and animals there from being exposed to parvo, a very serious gastrointestinal virus that puppies can get before they have finished a full series of vaccines.

I agree to release The Dog Spot and its agents and employees from any and all liabilities or claim due to injury to myself, my pet(s), or any other property of mine which may arise in any way out of services and/or products provided by or as a consequence of my association with The Dog Spot. The Dog Spot is not liable if my pet causes injury to him/herself, and is not liable for stress related illness that is out of the control of The Dog Spot. I release The Dog Spot, its agents and its employees from any liability or claim due to the death of my pet, unless The Dog Spot has been found negligent in the care of my pet. I understand that under no circumstances will The Dog Spot liability exceed the lesser of the current chattel value of a pet of the same breed or species or the sum of \$200.00 per animal.

I specifically agree that The Dog Spot shall in no way be responsible for death or injury should my pet contract kennel cough or another illness while at The Dog Spot. If my pet is found to have fleas and/or ticks, it will be treated by The Dog Spot at my expense.

I understand that during active play it is possible for injuries to occur. Some pets may play a little rougher than others, and at times tempers can flare in even the most docile of dogs.

I understand that incidents are not an everyday occurrence, but they do occur and are generally minor in nature. The most common injuries that we see—but certainly not the only ones—are minor cuts and punctures to the ears. Although these bleed, they are fairly minor in nature, but they may require attention for proper healing. Treatment normally consists of a visit to the vet for professional observation and assessment. Generally, the wound will be cleaned—stitched or glued if necessary—with a follow up round of antibiotics to prevent infection.

In the case of minor stress related symptoms such as: upset stomach, vomiting, loss of appetite, or scratches, I give The Dog Spot permission to administer to my dog the following over the counter remedies if necessary: Endosorb (Doggy Pepto Bismol), Imodium, Benadryl or Triple Antibiotic Cream.

No pet may be abandoned at The Dog Spot. Any pet that is left at The Dog Spot without any contact, instruction or notification from me, or without indication of the ability, willingness or plans to pick him/her up (by myself or my personal representative or agent) will be considered abandoned upon the seventh day of such notification failure. I understand that if I abandon my pet at The Dog Spot, The Dog Spot will proceed according to the guidelines provided by the State of Tennessee. I also understand I will be fully responsible for legal fees associated with the abandonment of my pet.
